

**Nashville Youth Soccer Association
Modified FIFA Laws
Under 4 Division**

Law I – The Field

- A. Field Size: 30 yd x 15 yd
- B. Goal Size: 5'W x 4'H x 3'D

Law II – The Ball

- A. Ball Size: three (3)

Law III – The Number of Players

- A. 6 players maximum per team
- B. On Field: 3 players and the coach. (3 v. 3) The coach or anyone filling in for a coach must be at least 18 years of age. Since the coach is on the field during the game, either one parent or an assistant coach is permitted on the player's bench side of the field during the game.
- C. No goalkeeper in this age division
- D. Substitutions may occur only at the quarter breaks, except in the case of injuries, for which substitutions may occur at any time with the permission of the referee.
- E. All players should play at least ½ of the game.

Law IV – Player's Equipment

- A. Footwear: Soccer cleats or tennis shoes (cleats are preferred). Baseball or Football cleats (cleats which contain a single cleat at the toe or very front of the shoe) are not allowed.
- B. Shin guards are required to be worn underneath the sock. The sock must completely cover the shin guards at all times. Players are not permitted to take the field without shin guards.
- C. ALL items of jewelry are strictly forbidden and must be removed prior to game time. This includes all necklaces and bracelets (whether string, leather, metal, or plastic), rings, earrings (including nose rings, tongue studs, and other piercings), leather bands, rubber bands etc. Using tape or band-aids to cover jewelry is NOT acceptable - the item must be removed. Furthermore, players must remove from their hair ALL hard clips, beads, or large bows. Soft "scrunchies" or pony-tail holders are permissible. The referees will inspect teams prior to each game and will ask a player out of compliance in this area to remove the jewelry or hair accessory.
- D. The player will not be permitted to play unless they are in compliance.

Law V – The Referee

- A. Certified or league approved Referee.

Law VI – The Assistant Referees

- A. Not used for this age group

Law VII – The Duration of the Match

- A. Length: The game shall be divided into 4 equal quarters of 6 minutes each.
- B. Breaks: There shall be a 2 minute break between the first and second quarter and the third and fourth quarter and a 5 minute half-time break.
- C. Teams shall not switch goals at half time. They are to play going the same direction the whole game.

Law VIII – The Start of Play

- A. The referee shall determine the team that kicks off with a coin flip or referee discretion.
- B. Opponents must be at least 3 yards from the center mark while the kick-off is in progress. The ball is in play when it is kicked or played forward into the opponent's half of the field
- C. A goal may be scored directly from a kick-off.
- D. The player kicking the ball on a kick-off must not kick the ball again before another player touches the ball.

Law IX – Ball in and out of play

A. The ball is out of play when it has wholly crossed the goal line or the touch line. The ball is in play at all other times.

Law X – Method of Scoring

A. A goal is scored when the whole of the ball crosses the goal line, between the goal posts and under the crossbar, provided that no infringement of the Modified Laws has been committed by the team scoring the goal.

Law XI –Offside

A. There is no offside offense in this division.

Law XII – Fouls and Misconduct

A. Fouls in this age group shall be called with an understanding of the age of the players. Fouls shall generally be limited to: a) handballs and b) excessive, dangerous, abusive, or violent conduct directed at another player.

B. All fouls shall result in an INDIRECT FREE KICK.

C. The referee and/or coach shall explain all infractions to the offending player.

D. There shall be NO SLIDE TACKLES.

Law XIII - Free Kicks

A. There are no direct kicks and all fouls shall result in an indirect free kick taken at the spot of the foul. The ball must be stationary on the taking of the free kick and the kicker shall not touch the ball again until it has been touched by another player of either team.

B. There shall be no free kicks taken by the attacking team within the defending team's goal area. If a foul is committed in the defending team's goal box, the ball shall be placed 5 yards away from the goal box for the indirect free kick.

C. The opposing team shall be at least 5 yards away from the ball when the free kick is taken.

D. The referee has the discretion to stop play and award a free kick to the defending team if play has become stalled or hazardous because of congestion of players around the ball. There are no drop balls in this age division.

Law XIV – The Penalty Kick

A. There is no penalty kick in this age group.

Law XV – Throw-Ins

A. There shall be no throw-ins in this age group. In all situations in which the ball has crossed the touchline and a throw-in would occur, the team which would have a throw-in shall have instead a free kick on the touchline at the spot where a throw-in would take place.

B. The player kicking the ball in cannot kick the ball again before another player touches the ball.

Law XVI – Goal Kick

A. A goal kick shall occur if the attacking team kicks the ball over the defending team's goal line without scoring a goal.

B. A goal kick may be taken from any point inside the goal area. The opposing team must be five yards from the goal box when the ball is kicked. A goal may be scored directly from a goal kick.

C. The kicker must not play the ball again until it has touched another player.

Law XVII – Corner Kick

A. A corner kick shall occur if the defending team kicks the ball over their own goal line.

B. A corner kick shall occur from anywhere inside the corner arc with the opposing team at least 5 yards away. A goal may be scored directly from a corner kick.

C. The ball is in play when it is kicked and moves.

D. The kicker must not play the ball again until it has touched another player.
